3. COMPOSITION/INFORMATION ON INGREDIENTS

TGF- β 3 human rec. produced in E. Coli is a disulfide-linked homodimeric, non-glycosylated, polypeptide chain containing two 113 amino acid chains and having a total molecular mass of 25.8kDa. The TGF- β 3 is purified by standard chromatographic techniques.
